

**Thank you for considering membership at the Saginaw Bay Yacht Club.** Below you will find information about the process and the types of membership available. Please review the information, complete the application and sign the form. Again, thank you.

#### SBYC By-Laws Article II, Section 2: Application for Membership

Prospective new members may be proposed by one (1) voting member who will sign the membership application endorsing the applicant. If the applicant is not brought forward by a voting member, the application will be referred to the Membership Committee. A member of the Membership Committee will meet with the prospect(s) to ensure SBYC membership will fit the prospects needs. The Membership Committee appointee will then sign the application form as the endorsing member. By signing the application form, the endorsing member is confirming they have reviewed and discussed the By-Laws, House and Dock Rules with the applicant. The applicant will also sign the application attesting to the accuracy of the information provided in the application and their agreement to abide by the By-Laws, House and Dock Rules. The properly completed membership application must be accompanied by full payment of the current Initiation fee. The Membership Committee will properly investigate the prospective new member(s) prior to making a recommendation to the Board of Directors. The Membership Committee shall direct the SBYC business office to post the names and residences of prospective new members, together with the name of the endorsing member on the Club bulletin board as well as email the same to all members with e-mail addresses on file with the club at least ten (10) days prior to being acted upon by the Board of Directors. The Board of Directors shall act upon the Membership Committee's recommendations at the next regularly scheduled Board meeting or special meeting called for that purpose.

Any prospective new member shall be accepted or rejected by a resolution passed by a majority of the Board of Directors present. A rejected prospective member shall promptly be refunded the initiation fee received with the prospective membership review form. The rejected prospective member may reapply after six (6) months from the date of rejection.

All prospective new member(s) in the Saginaw Bay Yacht Club shall be treated equally and no person shall be denied membership based on the prospective new member's religion, race, color, national origin, age, gender or marital status.

#### **Membership Classifications**

**Full** – This membership is extended to a single person or legally married couple that has attained eighteen (18) years of age. This membership includes the full access to the Club House and facilities, including Marina privileges.

**Social** - This membership is extended to a single person or legally married couple that has attained eighteen (18) years of age. This membership includes the full access to the Club House only, excluding all Marina privileges.
